

Local Handling within Singapore e.g. Transport | Mobile Cranes

- 1) Normal daily working hours start from 0800hrs and end at 1700hrs, from Monday to Saturday. Lunch time is strictly from 1200hrs to 1300hrs, which is not included in the daily rates.
- 2) Any operation works that is being ordered after 1700hrs, will be considered as night work. Night work / Sunday and Public Holidays will be based on a minimum of 8 hours.
- 3) Any operations that pass 2359hrs will be charged as 2 times the “daily work rate” based on per hourly rate
- 4) Working hours
0800hrs to 1700hrs = Normal
1700hrs to 2359hrs = Normal Overtime
2400hrs to 0800hrs = Night work Overtime (2x daily work rate)
- 5) All necessary documentation / permits to enter the Job sites / Jurong Port / Sentosa / Jurong Island / Changi Airport / any Military bases / and other restricted areas, shall be arranged by the hiring party or at least assisted by the hiring party.
- 6) All services offered are subject to equipment availability during time of booking / confirmation. We and our partners shall not be held responsible if our equipment is no longer available during time of booking / confirmation. It shall also not be the responsibility of SMP Global Pte Ltd and or our partners to source for alternative equipment from others. In the event others are quoting higher rates compared to us, SMP Global Pte Ltd and our partners shall not be held responsible for the increase of rates that were quoted by others.
- 7) Crane service charges will commence upon arrival of equipment at job site entrance gate and end upon exiting the gate of the job site. Further to this, all lifting points must be clearly marked on all cargoes.
- 8) Trailer service charges will commence upon starting of loading until the discharging of the cargo(s) from our trailers.
- 9) It is the hiring party responsibility to name SMP Global Pte Ltd as the named insured company for all risks and public liability (including goods being handled by SMP Global Pte Ltd)
- 10) Job cancellation charges are to be paid in FULL if cancelation takes place 1 day prior to the job execution
- 11) Hiring party must arrange and prepare for proper access at their sites for our cranes / trailers / staff and other equipment.
- 12) Any PE calculation or endorsement of ground assessment shall be borne by the hirer
- 13) Hirers must issue a PO to SMP Global Pte Ltd and must be sent to SMP Global Pte Ltd either by E-mail / Post / WhatsApp before SMP Global Pte Ltd will execute the order(s)
- 14) The rates quoted area subject to the prevailing GST rates, regardless of whether hirer is in Singapore or overseas
- 15) All ERP Gantry / ERP Car park / Illegal parking fees will be for hirer account, once job is completed these fees will be invoiced to the hiring party with supporting documents of prove
